State forfeiture funds were received through an Order of Forfeiture and Distribution related to DeKalb HIDTA MOU between DeKalb Police Department and DeKalb Sheriff's Office for cases #24-022210, #24-074926, and #25-024200. Court orders, MOU, and receipt of confiscated funds on file.

Federal expenditures include the purchase of four used vehicles purchased for Fugitive Unit (PO #5033834/Invoice SO250506-002) for Hardy Family Ford. Details of the purchases are on file and not provided due to the undercover activities of the Unit.

Cash on Hand includes interest income of \$25,650.60.
